LOCATION

With over 40,000 inhabitants including nearby villages, Barnstaple is a thriving town near to beautiful beaches and countryside, and the centre of North Devon in commerce, culture, education and service provision. It has a wide variety of businesses attracting tourists and permanent residents year-round, including a vibrant and diverse collection of bars and restaurants for evening footfall. Barnstaple is easily reached via the A361 which leads to the M5 at Junction 27, has a station with hourly trains to Exeter at peak times, and Exeter airport is an hour away. The town is rapidly expanding with several new housing and commercial developments currently underway, and more than 5,000 new houses and further economic development planned for the near future. The notable towns of Bideford (9 miles), Woolacombe (14 miles), Ilfracombe (12 miles), South Molton (12 miles) and Torrington (14 miles) are also nearby.

THE SITUATION

Benning Court was developed in 2008 and consists of office, warehouse, industrial and trade counter units off Riverside Road on Pottington Business Park. There are a variety of mixed users in the immediate vicinity including Screwfix and the Driving Standards Agency as well a number of regional and local businesses. Pottington Business Park has been subject to considerable development over the last few years including improved access from the downstream bridge.

THE PROPERTY AND CONSTRUCTION

Within a terrace of office units, the premises are of steel frame construction with double glazed windows to the front and rear. There is brick work to the exterior of the premises to approximately 4' (1.2 m). The first floor premises have a ground floor entrance lobby with a staircase as well as lift access with the offices providing circa NIA 3,788 sq.ft (352 sq.m). The accommodation is predominately open plan with the addition of meeting rooms and interview offices. Further specification includes double glazed entrance doors, air conditioning, suspended ceiling with recessed LED lighting, carpet tiles, IT trunking, fire system, kitchen, kitchenette, toilet facilities and disability friendly facilities. There is also on site car parking.
