LOCATION

With over 40,000 inhabitants including nearby villages, Barnstaple is a thriving town near to beautiful beaches and countryside, and the centre of North Devon in commerce, culture, education and service provision. It has a wide variety of businesses attracting tourists and permanent residents year-round, including a vibrant and diverse collection of bars and restaurants for evening footfall. Barnstaple is easily reached via the A361 which leads to the M5 at Junction 27, has a station with hourly trains to Exeter at peak times, and Exeter airport is an hour away. The town is rapidly expanding with several new housing and commercial developments currently underway, and more than 5,000 new houses and further economic development planned for the near future. The notable towns of Bideford (9 miles), Woolacombe (14 miles), Ilfracombe (12 miles), South Molton (12 miles) and Torrington (14 miles) are also nearby.

THE SITUATION

The premises are located on a trading Estate known as Riverview Commercial Centre which is located on Riverside Road. There are a wide variety of users in the immediate vicinity.

THE PROPERTY AND CONSTRUCTION

The end of terrace premises provides a floor area of 2,892 sq.ft (269 sq.m) with the premises constructed from a steel portal frame under a pitched and insulated profiled steel clad roof with 10% translucent roof panels. Externally there is brick facing as well as insulated profiled steel cladding, roller shutter door and 2 separate personnel access doors. Additional specification includes power floated floor, Three Phase electricity, LED lighting, kitchen and toilet facilities. The premises are currently configured with a trade counter reception entrance and 2 offices which comprise of 751 sq.ft (70 sq.m) of the floor area. There is car parking to the front of the unit as well as customer estate parking on a 'first come first serve basis'.

THE PROPOSAL

The premises are available by way of a new lease, held on a full repairing and insuring basis. A service charge is payable on an as costs arise basis for maintenance and upkeep of external common parts.
